REGULATION THE GRADUATE CLUB UNIVERSITY OF INFORMATION TECHNOLOGY AND MANAGEMENT IN RZESZÓW

I. General regulation

Regulation of the Graduate Club of the University of Information Technology and Management in Rzeszów, hereinafter referred to as "Regulation" define the terms of membership and the principles of organization of the University of Information Technology and Management in Rzeszów, hereinafter referred to as the "Graduate Club".

II. Mission

The mission of the Graduate Club is to integrate the community of graduates of the University of Information Technology and Management in Rzeszów.

III. Purposes

The Graduate Club pursues its mission through the following objectives:

- 1. Creating and cultivating bonds between the university and its graduates.
- 2. Organization of integration meetings.
- 3. Advice on professional matters.
- 4. Promoting opportunities for education and improving competencies, including: through postgraduate studies, training, and language courses.
- 5. Providing members of the Graduate Club with a database of job offers, internships and apprenticeships.
- 6. Promoting the image of graduates among employers, including: by posting on the website of Graduate Club profiles of graduates, as well as inviting graduates to various events, conferences/Career Days organized at the university.
- 7. Research on the professional path of graduates.

IV. Organization

- 1. The Graduate Club operates at the Careers Service of the University of Information Technology and Management in Rzeszów.
- 2. The Club's activities include:
- a. maintaining contact with university graduates,
- b. providing graduates with information regarding events organized for them,

such as workshops, training, consultations, integration meetings, etc.,

c. promoting graduates' profiles on the Graduate Club website,

- d. inviting graduates to various types of conferences/Career Days organized at the university,
- e. researching the professional fate of graduates in cooperation with the Needs Research Team,

3. The status of a member of the Graduate Club may be obtained by any person who has completed bachelor's, engineering or master's studies at the University of Information Technology and Management in Rzeszów.

4. The condition for acquiring membership is to complete the Declaration of Accession at the UITM Graduate Club available on the website absolwent.wsiz.rzeszow.pl.

5. Submitting the declaration is tantamount to accepting this Regulation.

6. Membership in the Graduate Club is voluntary and free of charge. A member of the Graduate Club may resign from membership by submitting a written resignation to the manager of the Careers Service of the University of Information Technology and Management in Rzeszów.

7. The main tool of communication between the Graduate Club and its members is the website absolwent.wsiz.rzeszow.pl and the newsletter.

V. Privileges

Members of the Graduate Club have the right to:

1. Receiving a Graduate Card entitling you to use the Discount Program.

2. Receiving an e-mail newsletter with information about the Graduate Club.

3. Participating in workshops, training and conferences organized by the University of Information Technology and Management in Rzeszów.

4. Using the resources of the Library in the Reading Room of the University of Information Technology and Management in Rzeszów.

5. Access to the database of job offers, internships and apprenticeships.

VI. Graduate Card

- 1. The Graduate Card is available to all members of the Graduate Club.
- 2. A person who comes into possession of the Card despite not completing the Declaration of Joining the UITM Graduate Club does not acquire the rights related to it.
- 3. The Graduate Card entitles you to use the Discount Program created for the Graduate Club.
- 4. The Graduate Card can be:
- pick up in person at the Graduate Club of the University of Information Technology and Management in Rzeszów,
- received by post (shipping at the expense of the recipient of the Graduate Card).
- 5. The Graduate Card becomes a document entitling you to use the Discount Program if:
- the Graduate Card number will be registered on the website absolwent.wsiz.rzeszow.pl,
- there will be a legible, handwritten signature of the owner on the reverse.
- 6. The Graduate Card is valid for 1 year from the date of registering the card number on the Alumni Club website. After the expiry of the validity period, the holder of the Graduate Card will receive an e-mail informing about updating personal data and reactivating the Graduate Card.
- 7. Activation of the Graduate Card after one year is subject to a fee. The activation cost is PLN 20. After activating the Card, the graduate obtains the right to use the Discount Program for the next year.
- 8. If a Club Member loses his Graduate Card, a duplicate is sent after paying a fee of PLN 20.
- 9. The full offer of the Discount Program can be found on the website absolwent.wsiz.rzeszow.pl.

VII. Personal data

 A member of the Graduate Club consents to the use and processing of personal data for the needs of the Graduate Club of the University of Information Technology and Management in Rzeszów in accordance with the Act of August 29, 1997, on the protection of personal data (Journal of Laws of 2002, No. 101, item 926). .)

2. A member of the Graduate Club consents to receive commercial information from the Graduate Club via traditional and electronic means of communication - within the meaning of the Act of July 16, 2002, on the provision of services by electronic means (Journal of Laws of 2002, No. 144, item 1204, as amended).

VIII. Final Provisions

- 1. This Regulation enters into force upon the establishment of the Graduate Club.
- 2. The University of Information Technology and Management in Rzeszów reserves the right to change the content of the Regulation. In the event of a change in the Regulation, a Member of the Graduate Club may resign from membership within 14 days of the change in the Regulation. The provisions of point IV.6 shall apply accordingly.
- 3. Any changes to the Regulation will be available on the website rekrut.wsiz.rzeszow.pl. Members of the Graduate Club will be informed about any changes via the newsletter.
- 4. A member of the Graduate Club undertakes to monitor any changes to the Regulation on an ongoing basis at www.absolwent.wsiz.rzeszow.pl and to become familiar with them.
